AIDS prevention and youth development in South Africa, Swaziland, Mozambique, and Lesotho. The program is carried out by Peer Educators in assemblies, classrooms, and groups, mostly in public schools but also in prisons, churches, drug rehabs, clinics, community groups, etc.

Grant to Phakama Africa Community Projects to carry out the Reach4Life AIDS prevention & youth development program in South Africa, Swaziland, Mozambique, and Lesotho. Due to COVID-19, the program was carried out in person when possible, and via online programming through social media - Zoom, Facebook, Whatsapp, texts, etc. when in-person wasn't an option. In 2021, there were 237,948 participants in the program. It is taught mostly in schools, but also in prisons, rehabs, community groups, churches, etc. We recorded 2,064 inmates attending R4L groups. Eighty thousand Bibles were made available for distribution in the four countries, including 2000 Portuguese Bibles (first time in that language). Reach4Life is being broadcast on 5 radio stations with a combined listening audience of 687,675. There were 492 indigenous Peer Educators who carried out the program in their own communities. They also helped schools with administering COVID temp checks, sanitizers, etc. They teach the program but also serve as role models in the communities and venues where they are working. Funds were also provided to expand the Reach4Life office in Soweto to create a training room.

Grant to Christ Fellowship Centre to build a church in Harrismith, Free State, South Africa. The building was completed before the end of the year and is now being used for church services, Reach4Life and pastor trainings, Reach4Life team meetings, community outreaches, and other events and services as needed.

Grant to Biblica for Reach4Life New Testaments to be used for curriculum and lessons on how to make wise life choices that will help participants avoid HIV and learn how to make the most of their lives. This year 80,000 Bibles were provided for the program.

Schedule F, Part I, Line 2 - QuickBooks accounting reports are provided monthly to the board president and treasurer for review. We have a bank account in the U.S. and in South Africa. Funds are wired from our U.S. bank account to our South African bank account, and disbursements are made from the South African bank account as needed. Phakama Africa Community Projects (the South Africa nonprofit organization that carries out the program) also has their books reviewed by an accounting firm locally. In addition to the accounting reports, we also receive reports that record where each Peer Educator (teacher) taught the program, including the name of the Peer Educator, name/location of school, prison, drug rehab, or other venue, number of people being taught, and lesson taught. The Phakama director and admin volunteers are based in Johannesburg. Each of the four participating countries (South Africa, Swaziland, Mozambique, and Lesotho) has a country coordinator and area coordinators, with teams of Peer Educators under them. The country and area coordinators serve as both teachers and administrators. We supply ongoing training materials to help make the Peer Educators become more effective in their work. This year, we did a revision of the Peer Educator training manuals (one for schools, one for prisons, and one for drug rehabs, including additional "dealing with addictions" materials). We also created a teaching manual on gender based violence (GBD), and material on grief counseling.
