Grant of \$186,059 to Phakama Africa Community Projects to carry out the Reach4Life AIDS prevention & youth development program in South Africa, Swaziland, Mozambique, Lesotho, Nigeria, Kenya, Tanzania, Uganda, and Zimbabwe. In 2022, there were 439,811 participants (up from 237,948 in 2021) in the program. It is taught mostly in schools, but also in prisons, rehabs, community groups, churches, etc. We recorded 30,308 inmates attending R4L groups. Reach4Life is being broadcast on 8 radio stations with a combined listening audience of 1,088,600. There were 634 indigenous Peer Educators who carried out the program in their own communities. They teach the program but also serve as role models in the communities and venues where they are working. (Includes \$945 for power banks due to the country's failing electrical grid.)

Grant to Christ Fellowship Centre for church building in KwaZulu-Natal Province, South Africa.
